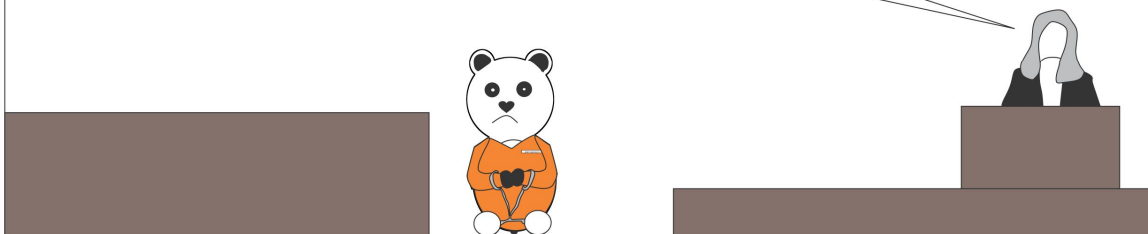
In standard abusive police tactics, Peter Panda attacked, electro-shocked, caned, and then arrested an un-armed, non-threatening panda.

Deorle, 272 F.3d at 1282; see also; Blankenhorn v. City of Orange, 485 F.3d 463, 480 (9th Cir. 2007).
